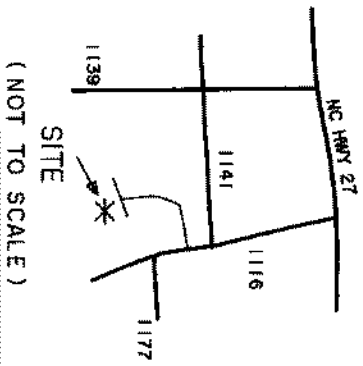
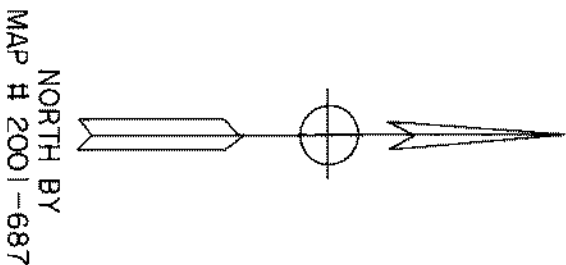




VICINITY MAP

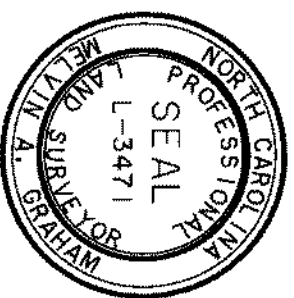

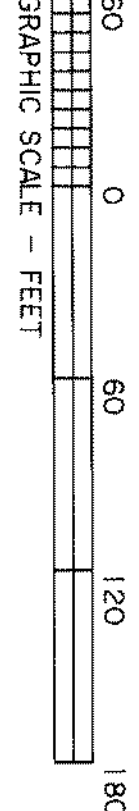
